Destination: Gans Creek Recreation Area, Columbia, MO

Meet at Songbird Station's parking lot at 8 a.m. We'll carpool to Gans Creek Recreation Area where we'll go on a 3/4 -mile walk to see two Great Blue Heron rookeries. There's lots of other land we can ramble on, or we may walk down Gans Creek Road that borders the recreation area where there are lots of birds in the trees along the road. The trip will be 3-4 hours long and will return to Songbird Station's parking lot.

Destination: Ozark Caverns, Lake of the Ozarks State Park, 823 Ozark Caverns Road, Linn Creek, MO Departure Point: AC Commuter Parking Lot

In August 2013, the Missouri Bird Conservation Initiative awarded Ozark Caverns a grant for small brush removal in an upland flatwoods in the park. CAS partnered with MoDNR on the grant, and in October 2013 visited Ozark Caverns before the thinning work was slated to begin to make a list of all of the birds seen or heard in the area. On that visit, we hiked through an area that had been restored in the mid-1990s to compare to the new restoration area. The thinning work will be completed at Ozark Caverns in April. CAS will revisit the site to document bird use in the area following the thinning project.

We'll carpool from the AC Commuter Parking Lot at 7:30 a.m. The lot is located just south-east of Highway 63 at the AC/Grindstone Parkway/New Haven Road exit. If you're not joining the carpool, meet at the Ozark Caverns Visitor's Center off of "A Road" at 9:30 a.m. After the trip we'll have lunch at the Seven Springs Winery in Linn Creek.

SATURDAY, JUNE 14

Field trip to private land in northern Boone County. The owners of an 80-acre tract of undeveloped land near Silver Fork Creek and the Pinnacles Park have invited Columbia Audubon and other natural history groups to visit their property, investigate its birds and plant life, and offer suggestions about management strategies. The area includes woodlands, meadows, a pond, and frontage on Kelly Branch Creek. If time permits, we may also visit another private tract in the area that is under a fire management regime.


once

The Eastern Bluebird was going, going, almost gone in the late 1960's. Loss of habitat to development and competition with house sparrows contributed to its decline. Nest box trails were established and have contributed to a now healthy population in Missouri. Now what's going, going, but hopefully not gone, are opportunities to have your "own" trail in a Columbia park.

The City of Columbia has bluebird nest box trails at 3M Flat Branch-Hinkson Creek Wetlands, Garth Nature Area, Forum Nature Area, Albert-Oakland Park, Cosmopolitan Recreation Area, and Stephens Lake Park. Mike Snyder of Columbia Parks and Recreation (CPR) asked CAS for a volunteer "bluebird coordinator" to assess the condition of the existing trails, lead a maintenance team, and consider development of trails at other sites. Jane Fore and I now share the illustrious position of Columbia Bluebird Coordinator. (I wanted a contest for a new title and Jane thought about holding out for a truck, but neither of those ideas was met with much enthusiasm

Bill Mees, Jane Fore, and I met with Mike Snyder at Bonnie View Nature Sanctuary to discuss the new collaboration. While we were there, we began installation of boxes for the City's newest nest box trail. We also asked two people using the park if they'd be interested in monitoring. Both said yes. So....

Please call me—Mary Williamson— at 449-7534 to get your own trail before they are all spoken for. Jane and I are happy to show you how we monitor. It's a ton of fun.

WILD HAVEN WORKDAY

To get to Wild Haven, take Route B north of US 63. After crossing RR tracks (about 1 mile), turn right at stop light onto Brown Station Road. Stay on this road through stop sign, then take the next right turn onto O'Rear Road. Follow O'Rear until it turns to gravel and then look for the Wild Haven sign, gate and picnic shelter on the right (about a mile from Brown Station).
